The form will remain on file with SCCA for the remainder of the year and awards for all remaining events in the current competition season will be processed automatically, unless the car is reported to the SCCA contingency department to be out of compliance for the program. • Non-compliant cars will not be awarded and the competitor will be required to re-submit a verification form signed by a licensed SCCA tech official. • Payments for all verified competitors will be issued by SCCA within 30 days of the receipt of official race results from the host region. • See “Payout Schedule” below for award amounts.
