# Time Trial/Novice Time Trial Application Instructional

**For Safe Keeping, Photo Copy All Correspondence Prior To Mailing**

**Please read before completing the application on the reverse side.**

## **Application Process:**

- A. Applicants must hold a valid full privilege Driver's License in their state of residence and be a current SCCA member.
- B. Applicants 18 years and older may apply to National Office, Member Services or their Regional Licensing Chairman for a Club Racing Novice Permit.
- C. **Minors:** The age of majority for licensing purposes is determined by the state law but is typically 18 years of age. Certain States may impose higher age limits and all license applicants must be of the age of majority for the state they are residing in. Please submit a completed *Minor Release and Waiver of Liability and Indemnity Agreement*, and *Minor's Assumption of Risk Acknowledgement* (MS-L form) must be in color. No one under age of sixteen (16) year of age may be issued a novice permit or competition license. Minors MUST apply to National Office for a Novice permit, or Region (if not a minor).

- D. Submit the following to **SCCA Member Services:**

### **Novice Time Trial**

Current SCCA medical form with only the medical history portion completed and signed by the applicant. If the applicant has a history of medical problems or has an obvious physical problem, the applicant is required to have a physician perform the medical examination on the reverse side of the Medical Form.

### **Time Trial**

Current SCCA medical form completed and signed by the applicant and physician. If the applicant has a history of medical problems or has an obvious physical problem, the application will be reviewed by the Divisional and or National Medical Administrator.

#### **Physician's Examination Requirements**

SCCA Competitor must have a current Physical Examination on file at SCCA National Office when applying for a novice permit. To obtain the Official SCCA Medical Form visit the SCCA website [scca.com](http://scca.com) or call Member Services.

***16-39 years of age every five (5) years***

***40-49 years of age every three (3) years***

***50-59 years of age every two (2) years***

***60 years of age and older every year***

***(Every blank on the Physician's Examination/Medical History MUST be completed)***

***Any known medical conditions which could affect your ability to compete must be immediately reported to the Medical Review Board per GCR 4.4.1.***

- 3. \$35.00 license fee.
- 4. Minors include the MS-L form.

## **UPGRADE**

Holders of either novice license who have participated satisfactory in three Time Trial events may apply to their Divisional Time Trial Steward for an upgrade to a Time Trial License. If upgrade is made within 90 days of original license, an additional license fee is not required.

## **APPLICATION AT EVENTS**

Novice licenses may be applied for and issued at registration, except for those under 18 years of age who can only have licenses issued by SCCA Central Licensing. The Divisional Time Trial Steward or Event Chairman will then forward the application and fee to Central Licensing for processing.

\*Please note all SCCA licenses will expire with membership
