

COVID-19 MANAGEMENT PLAN

This plan is subject to change as new information or requirements become available.



Guiding Principles

- Established protocols and requirements
 - Federal, State and Local Health Orders & Guidelines
 - Centers for Disease Control and Prevention
 - Recommendations for Personal Prevention Practices
 - Considerations for events and gatherings
- Collaboration between SCCA and Road America on accepted guidelines and practices.
- Plan elements from other motorsports entities
- The risk of COVID-19 exposure at events and gatherings increases as the number of attendees increase. SCCA and its participants must all do their part to mitigate the potential spread. Road America and its expansive footprint provides attendees the chance to maintain distance.



Face Coverings

- Participants are encouraged to provide for their own safety by bringing their own personal protection like face coverings. Limited supplies are planned to be on hand and distributed as needed.
- Face coverings must cover your nose and mouth.
- Face coverings will be required in all buildings, except in specific circumstances outlined in this document.
- Face coverings are required outside when 6 feet of distance cannot be maintained such as moving in and around the facility and crowds.
- Exceptions to the face covering requirement:
 - Face coverings are not required when with members of your household. This includes the people you are staying with during the event.
 - Event workers whose indoor workstation is at least 6 ft away from all others or separated by a plexiglass barrier may be exempt from wearing masks while sitting at the workstation. If you need to move from your workstation, you must put on your face covering.



Social Distancing

- Maintain 6 feet of social distance whenever possible.
- Limit time spent in indoor areas.
- Large gatherings are not permitted. As a rule of thumb, the number of people in a given area should not exceed 1 person per 36 square feet (6 feet by 6 feet) of open space.
- Avoid unnecessary physical interaction between officials, competitors, and other persons in attendance. Whenever possible, use electronic and radio interaction.
- Official event vehicles are limited to two occupants, with the exception of safety response vehicles.
- This does not apply when with members of the same household or those you are staying with during the event.



Health & Hygiene

- Do not attend the event if you are experiencing any symptoms consistent with COVID-19, including fever, respiratory symptoms, shortness of breath, sore throat, cough, fatigue or lack of sense of smell.
- Do not attend the event if you've been in contact with a known positive COVID-19 positive case in the previous 14 days.
- If you develop any symptoms while at the event, contact the Aurora Health Center immediately at 2600 Kiley Way, Plymouth, WI 53073; Ph: 920-449-7000.
- Avoid sharing equipment, tools or apparel, when possible.
- Wash and/or sanitize your hands regularly.
- Clean frequently touched surfaces, work areas and equipment.



Signage & Communication

- Road America signage to wear masks and maintain distance posted throughout the facility.
- Additional signs at indoor locations reminding people to wear masks.
- Regular announcements over the P.A. to remind people to wear masks and maintain distance.
- Text and email notifications to participants to wear masks and maintain distance.



Evening Activities/Awards/Meetings

- SCCA-supported dinners, award ceremonies and welcome parties will not take place to avoid creating large gatherings.
- A "Grab & Go" dinner option will be available October 6-10 to event volunteers. Alcoholic beverages will not be provided.
- Award ceremonies including Tire Rack Pole Awards and Worker of the Year presented by Mazda will be presented but will incorporate social distancing or possibly a live stream presentation.
- Post-race victory ceremonies will be held but policy TBD. (possibly after driver weighs, have them use hand sanitizer; driver mic for interview on side of stage)

Common Questions:

What do I do if I see someone not wearing a mask, even though they should be?

Some people have conditions or circumstances that would make wearing a face covering difficult or dangerous. Wear your mask as advised and stay six feet away. If this is an event worker, please let the specialty chief know.

How will the face covering requirement be enforced?

Specialty chiefs will be responsible for making sure each of their workers comply. Event participants are expected to follow these guidelines. Repeated warnings of noncompliance may result in participant being asked to leave.
