

## 2017 FORD PERFORMANCE SCCA U.S. MAJORS TOUR CONTINGENCY PROGRAM CLAIM FORM

**REGISTRATION:** Competitors must be officially registered to participate in this program with both SCCA and Ford Performance before the date of the event in which you will be competing. No awards will be paid if you are not enrolled prior to competing. Additionally, competitors must complete and submit this Claim Form no later than 30 days after the event after each eligible event.

**DECAL REQUIREMENTS:** All competitors must display four Ford Performance decals – a Ford Performance and Ford blue oval decal on each side of the car. The required decals are provided upon registration with Ford Performance. Additional decals are available by contacting Yvonne Harrison at Ford Performance: yharri10@ford.com or 313-854-1802.

**VERIFICATION/AWARD PAYMENT:** Product use and decal placements must be verified on-site by a tech official - who must sign this claim form. Claim forms may be signed to verify decal placements and product use prior to the posting of Official Results. Completed claim forms must be submitted with a copy of the Official Race Results and will be verified upon receipt. Finishing positions will be verified by the SCCA National Staff; awards will be made to legal finishers only. Payment will be issued by Ford Performance within approximately 45 days of claim receipt.
