No awards will be paid if you are not enrolled prior to competing in the event. **Additionally, competitors must complete and submit this Claim Form no later than 30 days after each eligible event.**

**DECALS:** All competitors must display three 12" or larger Chevy bowtie decals – Decals are required in highly visible locations on the front and each side of the vehicle. Decals are available by request from SCCA at [contingency@scca.com](mailto:contingency@scca.com).

**VERIFICATION and AWARD PAYMENT:** Decal placements and product use (must compete in a Chevrolet Sonic 1.8L 5sp hatchback with B-Spec kit P/N 23123679) must be verified on-site by a tech official - who must sign this claim form. Claim forms may be signed prior to the posting of Official Results. Completed claim forms must be submitted with a copy of the Official Race Results and will be verified upon receipt. Finishing positions will be verified by the SCCA National Staff; awards will be made to legal finishers only. Payment is issued by SCCA within 30 days of claim receipt.
