

## 2018 DIRTFISH HAWK PERFORMANCE RALLYCROSS NATIONAL SERIES CONTINGENCY PROGRAM CLAIM FORM

**REGISTRATION**: Competitors must be officially registered each year to participate in the program prior to competing. No awards will be paid if you are not enrolled prior to competing in an eligible event. **Additionally, competitors must complete and submit this Claim Form no later than 30 days after each eligible event.** 

**DECALS:** All competitors must display three Hawk Performance decals – one on the front and one each side of the vehicle. Decals are distributed by SCCA and may be requested from: contingency@scca.com

**VERIFICATION** and **AWARD PAYMENT**: Decal placements must be verified on-site by a tech official - who must sign this claim form. Claim forms may be signed to verify decals placements prior to the posting of Official Results. Completed claim forms must be submitted with the Official Race Results and will be verified upon receipt. Finishing positions will be verified by the SCCA National Staff; awards will be made to legal finishers only. Payment is issued by SCCA within 30 days of claim receipt.
