



SUPPLEMENTAL REGULATIONS

Because of how fluid COVID-19 is, it is creating situations that are subject to change with little or no notice. Please read the SUPPLEMENTAL REGULATIONS very carefully. Changes and/or Possible Changes that have been caused by COVID-19 are written in RED.

ALL RULES AND REGULATIONS THAT ARE COVID-19 RELATED ARE NOT PROTESTABLE.

Notice to Participants: In light of the current COVID-19 situation, every attempt will be made to minimize the risks of exposure to the virus. New regulations, processes and procedures are being developed and released which will be put into place for the event going forward.

Ultimately, it is your responsibility to assess the risk to you, whether it be on-track or off, and to make the decision on whether or not to participate. If you are sick or experiencing symptoms such as fever, cough, or shortness of breath, please stay home.

While onsite PLEASE take the HEALTH and SAFETY of your FELLOW PARTICIPANTS, VOLUNTEERS and STAFF into consideration and practice SOCIAL DISTANCING, WEAR MASKS AS REQUIRED and WASH HANDS and/or use HAND SANITIZER FREQUENTLY.

The following rules have been received from Mid-Ohio Management and are required for your weekend participation.

All participants must enter/exit via Gate #3. This is the normal gate you use to enter.

Upon entry to Mid-Ohio Sports Car Course everyone must have a medical health assessment form filled out and signed (assessment form is posted on MSR). We ask that you fill the form out prior to your arrival. Mid-Ohio will not have copies at the gate. There might be a very limited supply at registration. You are strongly encouraged to down load the copy posted in MSR. The completed form shall be given to the security guard at Gate #3. You will only need to complete the form the first time you enter the facility for the event.

Temperatures will be taken upon entering the facility. Temperatures will be taken each time for entry into the facility. If you leave and return you will have your temperature taken again. Anyone showing signs/symptoms or has a fever will not be able to enter the facility under any circumstance

<u>All participants must wear a mask at all times during their visit unless you are wearing a driving helmet for on track activity.</u> You may temporary remove the mask to eat, drink or smoke.

Social distancing practices MUST be maintained. <u>Currently Ohio defines social distancing as a</u> distance of not less than 6 feet and no groups greater than 10 people.

Minimize direct, physical contact between event attendees as much as possible, social distancing.

Mid-Ohio has added hand sanitizer locations throughout the facility. For your convenience, additional hand sanitizer stations have been added throughout the facility. Hand sanitizer locations;

Event participants are encouraged to use them as often as possible.

<u>Spectators are not permitted for the event. We ask that only those participating in the event attend</u> and that all non-essential family & friends remain at home.

No gatherings, cookouts, parties etc. may take place during your visit to Mid-Ohio. We ask that you follow state guidelines on social distancing.

Equipment with high-contact rates (radios, headsets, clipboards, pens etc.) should be sanitized before and between uses when they are shared.

If you become or start feeling ill while at the track, Mid-Ohio asks that you immediately return to your vehicle, leave the facility and contact Adam Fisher (419-631-7504 via phone to notify him.

The Sanctioning bodies would like to remind you that failure to follow these rules may lead to you being asked to leave the track. We do not want to see this happen.

This event is governed by the 2020 SCCA General Competition Rules (GCR), Category Specifications, as amended for 2020 per "FasTrack" effective June 1, 2020 release & these Supplemental Regulations.

I. REGISTRATION AND FEES

A. REGISTRATION: Drivers can register for the race online at <u>www.motorsportreg.com</u>. Due to COVID-19 online registration is the preferred. Drivers without internet access may request a paper entry form and mail it with their entry fees to the Chief Registrar:

Make checks payable to Ohio Valley Region, SCCA, Inc. A fee in the amount of \$30 will be charged for any check returned by the bank. A refund will be made if the entry is withdrawn prior to 11:59 PM, July 10, 2020; phoned cancellations must be followed up **in writing** to receive a refund. **No refund for cars that have been on the track any time for that sanction number**, "no shows" or because of weather. A **\$50 fee** will be collected for cancellations after July 10, 2020. If you sign in at registration and do not go thru or pass Tech, you must notify the Chief of Registration *BEFORE YOU LEAVE THE TRACK* in order to receive your refund. Phone/fax entries will not be accepted.

Please make every effort to enter this event as early as possible. Each race group will be limited to 65 cars after that number is reached, entrants will be placed on a waiting list for their respective group. The GLDiv racing regions have adopted a uniform policy on cancellation and late fees. These fees (along with other policy changes) are meant to prompt the entrant to register earlier.

Due to the need to social distance and abide by Covid-19 guidelines, Registration will be by appointment only. Each driver and crew will need to sign up for a registration appointment set up through SIGN-UP GENIUS. You can sign up for a registration appointment when you register for race or you can sign up for a registration appointment when you arrive at the track. You MUST come to registration at your appointment time. If you miss your appointment time, you will need to sign up for another appointment time. <u>NO WALK-UPS ALLOWED</u>. Late Entries will be given the opportunity to sign up for a registration appointment by calling the registrar or upon arrival at track. Please follow masks and 6 feet social distancing requirements.

Drivers must present their current hard card competition license when registering. SCCA members must present a valid membership card for admission. Worker license and membership card must be presented at registration. SCCA members and crew who arrive outside of the posted hours of registration will be required to purchase a pass to gain admission.

<u>14, 15, 16 and 17-year-old drivers:</u> Minor Drivers, as long as a current minor waiver is on file with the SCCA National Office and the driver's membership card shows "Minor Waiver on File", Mid-Ohio does not require any further paperwork. If the above requirement is not met, the driver is required to contact Tammi Griffith (Mid-Ohio) at tgriffith@midohio.com or 419-884-4000 for copies of Mid Ohio's











Minor Waiver. The Mid-Ohio waiver must be obtained well in advance & requires a Notary Public's signature. The completed Mid-Ohio waiver and information must be returned to Mid-Ohio 2 weeks prior to the event per the Mid-Ohio policy.

- B. Cancellation Fee Policy: A cancellation fee will not be assessed if the cancellation notice is made prior to the close of online registration at 11:59 PM on July 10, 2020. Once online registration closes at 11:59 PM on July 10, 2020, there will be a cancellation fee of \$50. This is necessary because it requires extra effort on our Registrar and Treasurer's part to process the cancellation so close to the event.
- C. Late Fee Policy: There will be a late entry fee of \$75 assessed if an entry is received after the close of online registration at 11:59 PM on July 10, 2020. This is necessary because it requires extra effort on our Registrar's part to hand process the entry after online registration is closed.
- D. U.S. Majors Tour Express Tech will also be available in the express line for those cardholders that have a valid Annual Tech, 2020 Helmet sticker (green) and no notations in their logbook. If eligible, you will only need to bring your logbook to Registration to receive your event "tech" sticker.
- E. ENTRY FEES: Entry fee for the three-day weekend is \$615. Each SM entry will be charged an additional \$20, and each SRF3, FE2 entry will be charged an additional \$30.00 compliance fee per entry for the weekend. Late Entry: Add \$75.00 to the total amount if postmarked after July 10, 2020. Double Entry fee is \$950 (both races both days). Must be same car with same driver for this discounted fee.
- **F. ENTRY FEE PAYMENT:** Drivers who complete their registration online, via the motorsportreg.com website will pay by credit card or by check (mailed to the Registrar (Registration is not complete until the entry is paid). Drivers registering at the track or by mail can pay by check, cash, or credit card.
- G. PASSES: Each car will receive three (3) passes, including the driver and two (2) crew. Additional passes cannot be purchased. Spectators are not permitted for your event. We ask that only those participating in the event attend and that all non-essential family & friends remain at home. Workers and crew must sign for their own passes and must arrive while registration is open. Only the entrant, driver, or designee (authorized in writing) may change the crew list.
- H. GARAGE RENTAL: Garages are priced at \$300 per garage (max. of two cars per garage). Contact Peggy Dietz, Registrar, fford18@roadrunner.com, 330-460-6706. Make check payable to Ohio Valley Region, SCCA, Inc.. See the garage contract for cancellation details.
- I. FREE ENTRY GIVEAWAY: A free entry will be awarded to one driver registering for the event 14 days prior to the weekend. Driver name will be drawn during the weekend.
- J. PREFERRED NUMBERS: Every effort will be made to honor Conference Preferred Numbers until 14 days prior to the event. Due to the make-up of the run groups, however, this may not be possible in all situations. If two drivers holding the same Preferred Number request that number for the same run group, the number will be assigned to the driver with the earliest request. At noon on June 26, 2020, all unused reserved numbers will be released. Confirmation email will be sent only if you don't get your first choice of number. Correct number must be on car prior to tech.

II. DRIVER INFORMATION

- A. DRIVER ELIGIBILITY: Drivers must be a current member of the SCCA and have a current SCCA Full Competition or SCCA Pro License to participate in this event. If you do not have the proper credentials, it is your responsibility to contact the Registrar prior to the event. Competitors whose licenses are pending must call the registrar by July 14, 2020, so that the license can be confirmed and there will be a \$10 charge for this service. In 2020 membership and licenses issues will not be able to be verified with the SCCA National Office after 5:00 PM CST on Friday night. After that time, the National Office will be closed until Monday morning. If your membership and/or license cannot be verified, you will be required to complete and sign a Statement of Fact Affidavit along with paying a \$100 deposit, of which \$75 is Refundable upon verification.
- B. CAR ELIGIBILITY: Competition is open to all cars conforming to the GCR, as amended.
- **C. TECH:** All drivers without a current year helmet sticker must present all driver gear as required by the GCR, vehicle logbook, and completed tech card to get their event tech sticker. If your car requires an annual tech you must also bring the car to Tech. If you need an annual tech, contact the Chief of Tech to set up an appointment, no walk-ins please. Tech is located at the rear (South side) of the Maintenance Building.











- **D. EXPRESS TECH**: Drivers with both a current annual tech and a 2020 green helmet sticker may bring just their vehicle log book and completed tech card to get their tech sticker. Express Tech is a special window at Registration, or you can go to Tech at the Maintenance Building.
- E. TIMING AND SCORING: All cars are required to use a fully operational MyLaps/AMB TranX260 transponder or X2 transponder. The location of the test loop is the Tech Inspection area, and it will be staffed the same hours as the Scales. The driver is responsible for providing correct information to Timing & Scoring. <u>Make sure that your transponder is on for all sessions.</u> Cars without working transponders will not receive times. Efforts will be made to broadcast sector times for all sessions.
- F. COURSE: Mid-Ohio Club Course is 2.4 Miles. All Race Starts, Restarts and Checkered Flags will be from the front straight start stand. All race and qualifying timing will begin and end at the timing loop in front of Timing & Scoring. The loop is marked by orange cones on each side of the track and is 115 feet before the Mid-Ohio checker pattern on the track. For practice, qualifying and warm-up, the session clock will start when the first car crosses the pit lane timing line. For all races, timing will start when the front row crosses the front straight timing line after the pace lap. The clock will continue to run during all flag conditions with the exception of a red flag.
- **G. PACE LAP:** The Pace car will pace the field to the Pit Lane entrance then exit the track surface at the Pit Lane entrance. Be prepared for this to happen. Front row will then pace the field until the green flag is given.
- H. RACING SURFACE: The Pit Out Lane (drivers left of the curbing and/or colored line) is not part of the racing surface. Any driver who uses it as a racing surface by putting two or more wheels to the left of the curbing/line, whether in qualifying or the race, may be subject to a penalty. A driver who forces an overtaking car or a car being overtaken into the Pit Out Lane while a pass is being attempted may also be subject to a penalty for violation of GCR 6.11.1.B, failure to provide racing room on the marked racing surface.
- I. BLACK & "MEATBALL" FLAGS: The Black flags may be displayed at the Starters Stand at Start/Finish and/or turn 11 on the left before the Carousel turn and the Pit entrance.
- J. BLACK FLAG REPORTING AREA: The Black Flag reporting area is in the area (black flag) at the base of the start/finish stand on pit lane.
- K. SOUND CONTROL: Sound control will be enforced for this event: The sound meter is located at exit of Turn #2 (the Keyhole) on the left. Participants are encouraged to comply with the sound limit specified in the GCR which is 103 dB. Cars exceeding 103 dB in a session will be shown the closed black flag and the "sound" board for their first two readings. If a third reading greater than 103 dB is recorded in that session, the car will be black flagged and must report to the pits. The car may not return to the track until corrective steps have been taken per GCR. For your information, sound readings will be posted at the base of the tower.
- L. WARM-UP SESSIONS/HARDSHIP LAPS: Sunday warm-ups are open to all. Hardship laps between sessions may be possible. Requests for a hardship lap may be made at the Black Flag station and passed on to the Race Director for approval subject to reasonable conditions on track.
- **M. AWARDS**: Trophies for all races will be awarded in accordance with the GCR. Trophies will be presented at the event. SCCA Majors Points and Hoosier Super Tour points will be awarded in accordance with the GCR and these supplemental regulations.
- N. VICTORY LAPS: Winners of all races will receive a checkered flag, however, for Sunday races only, following the cool down lap. The winner of each class should proceed immediately to Pit Central where they will receive a checkered flag and proceed on course for a single Victory Lap. Drivers need not wear their helmet or gloves during the victory lap; passengers are permitted in accordance with GCR 6.11.7. <u>Drivers shall maintain a safe speed and be wary of safety vehicles which may be on course.</u>

III. CAR SAFETY AND TECH INSPECTION

- A. DECALS: A U.S. Majors Tour decal and Hoosier Super Tour decal must be displayed on both sides of all competition vehicles. Competition vehicles must also display the official Summit SCCA Road Racing decals per GCR section 9.3.29.C. Stickers will be provided free of charge and may be obtained at Registration and/or Tech. The official SCCA Summit Racing Equipment Road Racing decal does not serve as the Summit Racing Equipment contingency program decal.
- **B. DATA ACQUISITION**: Majors staff and their delegates may install data acquisition equipment in a competitor's car. This program is to assist the CRB in performance balancing. If selected, participation is NOT optional













and is NOT protestable. The data collected from the device will not be used for compliance purposes.

All cars carrying an SCCA data collection device shall report to impound and be weighed immediately after their session.

- C. SPEC MIATA COMPLIANCE: At post-race inspection, Spec Miata participants may be instructed by the designated Class Compliance Chief (CCC) to remove parts, including but not limited to the cylinder head, for disassembly and/or inspection. Competitors are responsible for performing required disassembly and/or reassembly of their car, as well as any resulting expenses incurred. The CCC will report any findings of non-compliance to the Race Director, who will then determine the need for a Chief Steward's Action (CSA) or Request for Action (RFA). Post-race inspection shall be limited to driver and only 2 crew members. Masks and social distancing regulations must be followed.
- **D. SCALES**: Will be available at Tech Friday & Saturday 7:30AM-11:30AM, Sunday 7:30AM-9:00AM. Scales may be made available at other times at the discretion of the Chief of Tech.

IV. Qualifying

A. GRID: <u>Starting positions for the Practice session will be based on entry time & date. Starting position for the first Qualifying will be based on fastest time from Practice.</u> Starting position for the second Qualifying will be based on fastest time from first Qualifying session.

Starting positions for the Saturday Timed race will be determined by the fastest time recorded for each car during the preceding qualifying sessions. Starting positions for the Sunday Distance race will be determined by the fastest time recorded for each car during each of the preceding qualifying sessions and their fastest lap during the Saturday Timed race. Cars arriving late to grid, after their group has been dispatched on track may, at the discretion of the Operating Steward, be held at pit out and released at the end of the pack after the field has completed the pace lap.

B. QUALIFYING: Per the 2020 GCR, A driver not qualifying within a maximum of 115% of the recognized track record of their class must obtain permission from the Race Director in order to race. In the case of unusual circumstances, the Race Director can waive this rule for the entire event. See Chart below:

V. IMPOUND

- A. DRIVER'S MEETING: A Drivers Meeting Letter will be posted in MSR with the final version of the Supplemental Regulations and copies will be available at registration. Updates will be communicated through MSR via email and/or text when possible. Text is hit or miss unless you have Verizon.
- **B. SPLIT STARTS:** The Race Director will consider requests for split starts. Drivers interested in split start shall see the Race Director as soon as possible following their respective Qualifying Session on Saturday. Updates will be communicated through MSR visa email and/or text when possible. Text is hit or miss unless you have Verizon.
- C. IMPOUND: Driver's shall listen for announcements concerning impound. If Impound occurs, it will be limited to driver and 2 crew members. Wearing of masks and social distancing rules must always be followed in the tech area.











<u>Saturday Races</u>: **Only the top three competitors in each class** shall report to impound immediately following the completion of their race. Trophy presentations and photos will occur in the Tech area following the race.

<u>Sunday Races</u>: **Only the top three competitors in each class** shall report to impound immediately following the completion of their race. Victory celebrations and award ceremony will be conducted at the Victory Circle in the Tech area following Sunday's races. U.S. Majors Tour door prizes will be awarded after each group's podium ceremonies; you must be present to win.

- D. CONTACT: GCR Section 6.11.1.E requires involved in significant body contact (contact that results in a change in position, causes another car to spin or put two wheels off, or a significant impact with another car or barrier) drivers of vehicles are required to report to the stewards for a review of the incident. Drivers shall satisfy this requirement by seeing the Race Director or Chief Steward during the scheduled 30-minute Impound for their group. Drivers who do not satisfy this requirement will be referred to the Stewards of the Meeting.
- E.. PASSES UNDER YELLOW FLAG: All pass under yellow reports will be investigated. All drivers shall follow GCR Section 6.1.1.B. A violation of this section will result in penalties as outlined in the 2020. Standard Penalty Guidelines.

VI. <u>GENERAL</u>

- A. RACE LENGTH: Saturday races will be 25-minute races. Sunday races will be 35 minutes (21 laps max.), whichever comes first. There is a total of 7 Race Groups. The track length for the Club course is 2.4 miles; per GCR 6.4.1.B amended, maximum of 65 cars per group.
- **B. RESULTS**: Live timing will be available during the event. Unless otherwise announced, live timing will be available via the Race Monitor App available for IPhone and Android phones. Efforts will be made to broadcast sector times during all sessions. Live timing is neither official nor protestable.

Qualifying, provisional and final results may be posted at the Tower (Driver Info) if the Tower area is open. Drivers may obtain a copy of the final results after the results are final. Additionally, final results will be posted to the Region's (ovr-scca.org) and SCCA websites no later than 7 days following the completion of the event.

- C. START TIMES: Schedule Times are cars on course.
- D. EVENT SCHEDULE/RUN GROUPS: Actual session start times may be delayed from the published schedule due to unforeseen circumstances during the event. Listen to the PA system (if operating) and pay attention to what is happening on track. It is the responsibility of the driver and crew to be at grid on time. The event schedule or run groups may only be changed (or start times advanced) at the discretion of the Race Director, with concurrence by the Event Chair, depending on pre-race entry counts or as needed to accommodate situations that may be encountered during the event. If changes are made prior to the start of the event, as much notice as possible will be given to all affected competitors.
- E. CANCELLATION: If part of an event is cancelled for reasons of safety or forces beyond our control as provided in GCR Appendix B 1.2, points will be awarded based on race grids.
- F. CLOTHING: <u>Shirts, long pants, and closed shoes are required in the pits</u>. No exceptions unless approved by the Chief Steward. Crew members on Pit Lane must display their event credentials at all times while on Pit Lane.
- **G. PIT LANE**: Drivers are to maintain a safe speed on pit lane with absolutely no racing. Minimum age in the pits is 18 years.
- **H. WELCOMING ENVIRONMENT**: The Ohio Valley Region of SCCA, aims to provide an inclusive, welcoming environment for all participants. To that end, behaviors such as the following will be considered egregious examples of GCR 2.1.7, "Acting in an unsportsmanlike manner", and will be penalized as such.
 - Discriminating against, disparaging or verbally abusing a participant because of their gender identity, ethnicity, marital status, sexual orientation, religion, age, or disability.
 - Harassing, intimidating, threatening or bullying a participant.
 - Doing any of the above outside the confines of an event in print or electronic media, in a way that affects that person's participation at an event.











- I. LAST LAP INDICATOR: Whenever possible, a waving white flag and the "1 to Go" sign will be displayed at Start/Finish to indicate the last lap has begun. The failure to display a last lap indicator is not protestable. "When the LAST LAP INDICATOR is given at Start/Finish the next flag will be a checkered flag".
- J. **RADIO FREQUENCIES**: No radios will be permitted which interfere with track communications, 151.625, 151.805, and 154.600. These frequencies may be monitored but shall not be used for communication by any participant.
- K. DISABLED CARS: Disabled or damaged cars may be removed from the course and delivered next to the false grid. If the car has sustained body/chassis damage, it will be released to the driver/crew after Tech has made appropriate notations in the Vehicle Log Book. Cars disabled due to a mechanical failure will be released to the driver/crew immediately.

If the car requires wrecker support to return to its paddock location, there delay depending on the availability of wreckers or flat tows.

- L. PACE/SAFETY CAR: In addition to GCR 6.6.2, the field shall follow the PACE/SAFETY car as long as its emergency lights are flashing, even if it varies from the normal race course. If a full course yellow results in dispatch of the Safety Car, the Safety Car will enter the racing surface at Pit Out and will be waiting on the field just around the corner from station 1.
- M. INSURANCE: Participant insurance will be provided in at least the minimum amounts required by the SCCA.
- **N. SPECIAL**: Paddock speed limit is 10 MPH. Anyone operating ANY motorized vehicle on the track property must have a valid driver's license (any state) and present it to any official upon request. Skates, Razors, scooters, & skateboards (with or w/o motor) are banned. Unlicensed motor scooters, motorcycles, ATV's, etc. cannot leave the Paddock except to go to the Grid or Showers. Golf carts do not need a license.
- J. DRONES AT THE RACE TRACK: Commercial Unmanned Aircraft System (aka "Drone") owners/operators must have proof of FAA certification and \$10M of primary liability insurance naming the SCCA, the Sponsoring Region(s) and the Race Track as additional insured. A general liability insurance policy must specify that it includes the operation of Unmanned Aircraft. Recreational use of unmanned aircraft is prohibited.
- **K.** Fuel spillage on any paved area of the facility is forbidden and may result in liability for repairs if instructions from any officials are not obeyed promptly. Jack stand bases must be supported so as to avoid pavement indentations. No unmuffled engines may be operated between 7 PM and 7 AM unless traveling to or from Tech on Thursday evening.
- L. TIRE VENDOR: Hoosier Tire Hours to be determined. Other Tire Vendors to be determined upon their request.
- M. FUEL: Mid-Ohio Fuel Pumps open during racing hours. Contact Dave Schwall @ 419-564-4082.
- N. Overnight Stay: Staying overnight maybe be allowed, but no gatherings. This will be permitted on Thursday, Friday and Saturday nights only. The area is limited to the paddock. You maybe required to stay in your rig or motorhome.
- **O.** <u>At the current time, the infield will be closed and there WILL BE no spectating in the infield.</u> As always, the GRANDSTANDS CLOSED.

VI. MISCELLANEOUS:

Sale of any products on Mid-Ohio property is strictly prohibited without prior written permission from Mid-Ohio and OVR-SCCA, Inc. Contact Nolan Podmore @ 330-631-3969

Please use the provided receptacles for trash, oil, and other fluids. Do not leave any tires at the track, except with tire vendors.

You will be required to vacate the premises by 6:30 PM Sunday. If later, you will be billed for the cost of Security.
