Requirements:	<ul style="list-style-type: none">* Competitor must race with Hoosier Racing Tires on all four wheel positions* Decals Required: YES, Three (3) on all classes. Location: One (1) decal on <u>each side</u> and one (1) decal on the front. No exceptions will be made for this rule. No competing tire decals, and decals must be contrasting colors from the race car. It is the competitor's responsibility to register properly and neatly apply decals. Decals used must be the officially supplied Hoosier Decals. Availability: Decals, will be mailed if requested at registration. Additional decals are available by contacting Paula Nate at pnate@hoosiertire.com* Geo-tagging or Location Services MUST be enabled on your smart phone or tablet so that we can verify that the submitted photos are taken before your race session.

Award Information:	<ul style="list-style-type: none">* Product awards are presented to all eligible 1st and 2nd place drivers per class in the 2022 Tire Rack SCCA National Tour competition.* Contingency forms must be completely filled out and include all supplemental information; copy of official results@geotagged photos.* A copy of a paid invoice is required and must accompany all redemption forms submitted. Solo participants can claim twice the amount of tires for contingency that is listed on the paid invoice. e.g., buy a set of four (4) Hoosier Tires and claim a maximum of eight (8) contingency tires for that invoice. Contingency awarded tires or random draw tires (i.e., no charge tires) will not be eligible for contingency.* Hoosier will also award all year-end class champions and the overall Super Challenge Champion.* A minimum of five (5) competitors are required in a class to claim 1st place awards, and seven (7) cars are required to claim 2nd place awards.* Competitors may only submit claims for the same size tire for which they competed and which they can provide proof of purchase.* Any tires received through this program are for the recipients use only and are not to be sold. The Hoosier Racing Tire Contingency Program makes no provisions for freight, mounting and balancing.* All awards must be claimed within 30 days of each eligible event.* See "Payout Schedule" below for award amounts.* This is a basic contingency program administered and paid entirely by Hoosier Racing Tire.
