2023 VIR Paddock Vehicle Permit Registration & Agreement

Golf Cart, ATV and Other Authorized Vehicles

SCCA Runoffs Participant OWNED ("Participants" include registered drivers, entrant, crew, workers - Coverage provided by SCCA Event Insurance)

- Acknowledges and agrees that the vehicle shall be operated in compliance with the vehicle manufacturer's operating instructions and/or industry standards including those regarding riding/driving position and number of passengers and has a minimum seat height of 24 inches. Hoverboards or single wheeled vehicles are not permitted at VIR.
- Acknowledges and agrees that all operators of said vehicles shall be at least 16 years old, have a valid state-required driving license and carry adequate liability insurance applicable to the operation of their Paddock Vehicle and that all operators shall provide such license, proof of insurance and other applicable credentials upon the request of a Racetrack or event official. If a Paddock Vehicle displays a state issued license plate, a valid registration card must be on hand with the vehicle to be exempt from the Paddock Vehicle Pass requirement.
- · Hereby assumes full responsibility for and assumes the risk of any bodily injury, death or property damage arising out of or related to the use of said vehicles, whether caused by the negligence of owner and/or their operators, pedestrians, Racetrack, Paddock Vehicle operators or otherwise.
- Acknowledges that all registered Paddock Vehicles MUST display the owner's current VIR Paddock Vehicle Registration Sticker on the front left (Driver's) side of the vehicle. Stickers are not transferable.
- Acknowledges that the Paddock Vehicle will be operated in a responsible manner and according to all regulations and instructions, including but not limited to posted speed limits, designated roads, hours of operation and allowed locations.
- Acknowledges and agrees that unsafe or improper operation of the Paddock Vehicles and/or any violation of regulations and instructions may, at the sole discretion of Racetrack, result in penalties against the owner and/or operators including, but not limited to, immediate impoundment of the off-road vehicle, loss of racing privileges for the day for a first offense, and for the season for the second offense.
