**SUBJECT:** 2024 Toyota/TRD USA Contingency Award Program

Included in this packet is the information you will need to enroll in the 2024 Toyota/TRD USA Contingency Program (the "**Program**").

IMPORTANT: Contingency claims MUST be made within 30 days of the event completion. See the attached Contingency Award Guidelines for more information.

Toyota requires that the Toyota logo "" be included with the word "TOYOTA" in all uses. The decals that are distributed by TRD include the required logo.

You must be enrolled in the program prior to the date of the event in which you will be competing. If you are not enrolled before competing in an eligible event, your claim will not be paid.

To enroll in the program, please complete **both the Registration** and the **Contingency Award Guidelines** forms included below (pages 2-5) and e-mail them to TRD per the instructions at the bottom of the form. TRD can only accept the fillable .pdf files attached here, sent to us via e-mail to the contact person listed in the Contingency Award Guidelines below.

**Parts Ordering:** If you are planning to purchase Toyota parts during 2024, see the attached <u>Parts Guidelines</u> for more information.

## 2024 TOYOTA/TRD CONTINGENCY AWARD GUIDELINES

Following are the guidelines for any applicant seeking to participate in the Contingency Award Program offered by Toyota Motor Sales, U.S.A., Inc. ("Toyota") and TRD, Inc. ("TRD") (collectively referred to as "Toyota").

1. Applicants must comply with all federal, state, local laws and applicable competition and sanctioning body rules and regulations in effect at the time of the event.

2. To enroll in the program, a completed 2024 registration form must be submitted to TRD prior to March 31, 2024. Please note that the only registration or renewal forms accepted are the electronic fillable pdf forms included with this packet. The required form must be completely filled out and sent to the e-mail address indicated on the form. Hand-written forms or faxed forms will be deemed ineligible. Please indicate who the driver will be on the form.

3. SCCA Racers: Awards will be granted only for those individuals racing in a Toyota, Lexus, or Scion Vehicle in the following SCCA-sanctioned events: U.S. Majors Tour events and Runoffs Qualifier Club Racing Regional events (each, an "event"). All details of the events are in sponsor's sole discretion and by participating/driving, you agree to abide by those decisions and these Guidelines.

4. Toyota Race Vehicle Requirements: In order to be considered for an award under this program, each competitor must display official TRD logo stickers, as supplied once by TRD, prominently affixed to both sides of the entered Toyota vehicle. In addition, each competitor must display the Toyota ( 💬 ) logo and "TOYOTA" in 4.5-inch tall (or larger) letters (black, white, or red only) on the race vehicle, one on each side and one forward-facing.

5. Scion Race Vehicle Requirements: In order to be considered for an award under this Program, each competitor competing in a Scion model vehicle will be eligible for awards at the same levels and in the same classes applicable to the Toyota program. There is no separate Scion program. Competitors must display official TRD logo stickers, as supplied by TRD, prominently affixed to both sides of the Scion race vehicle in order to qualify for an award.

6. The registration form has an area to request the stickers and die-cuts ("decals") that you are required to include on the vehicle to participate. Replacement decals are available from TRD upon request by e-mailing <u>trd.contingency@toyota.com</u>. Please only request additional decals if you need them.

7. All Contingency Award Claim Forms (copy below) must be accompanied by a copy of the official race results, along with a photo of decal placement, and submitted no later than 30 days after the applicable event date.

• Claims submitted more than thirty (30) days after an eligible event will be disallowed. This rule is and will continue to be strictly followed. Late claims will be deemed ineligible and will be denied.

• First time claimants must fill out the attached W-9 form and submit it along with the Contingency Award Claim Form. If an award applicant fails to submit the required W-9, Toyota will not be required to consider the applicant's claim or make payment.

• If contingency awards are to be paid to someone other than the driver, both the driver and the claim recipient must endorse the Contingency Award Claim Form.

8. Contingency Program awards are listed on the Registration Form below ("Program Awards").

• In the event of a tie between two Toyota competitors, the competitors will share equally from the combined awards for that position and the next lower level award.

• No Program Award money will be paid to a participant who fails to finish an event. Program Awards are based on finishing position only (championship awards are exempt from this rule).

• Only participants competing in vehicles with a Toyota or Scion engine and body are eligible for award payments. Exceptions to this rule are Toyota-powered Formula Atlantic Racers.

9. Any competitor disqualified at the SCCA National Runoffs will forfeit any and all contingency awards earned at the Runoffs, including tow money.

10. Each applicant/participant agrees to indemnify, release and hold harmless TMS, TRD, their parent and other affiliated companies, dealers and distributors, and their respective agents, officers, directors, employees, representatives and contractors from any and all liability for any loss, judgments, damages, costs or expenses, claims and actions of any kind (including reasonable legal fees) arising from or related to the following (i) applicant/ participant's participation in any racing event and/or this Program; or (ii) violation of a third party's rights arising from Toyota's use of applicant/participant's Likeness as permitted herein (including claims based on publicity rights, defamation or invasion of privacy, copyright infringement, trademark infringement and/or any other intellectual property right).

11. Each Program participant consents to the use by Toyota of their name, team name, nickname, voice, photograph, likeness, statements, image, biography and background information, social media/online profiles and handles and all related intellectual property (collectively "Likeness"), for advertising, promotional or any other purposes in any medium throughout the world in perpetuity without additional compensation or consent unless prohibited by law.

12. Failure to meet all of the terms and conditions listed above can result in Toyota denying payment of contingency awards and dismissal from the Program.

13. This Program is subject to all applicable federal, state and local laws and is void where prohibited or restricted by law. Toyota reserves the right to amend or cancel this Program at any time. All money paid under this Program is reported to the Internal Revenue Service along with the recipient's name, address and social security number/federal I.D. number.

Components purchased through this program are never to be resold and are intended for the sole use of Toyota and Scion racers on their racing or tow vehicles ONLY.

# ORDERING

Place orders for Toyota and Scion replacement parts and TRD Performance Parts with any Toyota/Scion dealer, be it your local dealer or one on-line that can provide the best price.

# **REBATE**

For the period November 1, 2023, through October 31, 2024, submit a summarized invoice along with copies of your original invoice(s) to TRD no later than November 1, 2024. You will receive a check (or EFT if on file) for 10% of your total purchase (not including sales tax) before the end of 2024. You must be registered for the 2024 Toyota/TRD Contingency **Program prior to filing a rebate or your rebate claim will be denied.** <u>A W9 also needs to be on file</u> (does not need to be submitted yearly). If you have been paid contingency in the past, you have a W9 on file. Otherwise, please include one with your registration or renewal. A rebate will not be granted for parts that cannot be used on your racecar or your tow vehicle.
