GENERAL RULES: This event is held under SCCA Test Day guidelines as outlined in the General Competition Rules (GCR), the Category Specifications, and as amended for 2024 per “FasTrack”, on the Virginia International Raceway, 3.27mi full course.

DRIVER AND CAR ELIGIBILITY: This is a closed Test Day. Only Runoffs-eligible classes and drivers already registered for the subsequent Hoosier Super Tour at VIR, are eligible to participate in this Test Day. Test Day Entry fees are per driver, not per car.

TECH: All test day cars must meet Spring Sprints HST event tech requirements. Please plan time to go through the tech process.

LOAD IN: Wednesday and early Thursday Load-in will be available for Test Day participants only. Regular entries can load in, with assistance, beginning at Noon on Thursday after they have been through SCCA registration. Camping and Electrical passes should be purchased from VIR.
